- Communicating action items and weekly League news in a consistent manner.
- Registering thousands of new voters!


And most important, a hearty thank you to **ALL** who have volunteered countless hours and days to further the League mantra of "Making Democracy Work for All!"

Mary Ann Palmer: Where Has the Time Gone?

When Mary Ann Palmer was asked for some memories we could share about her 50 years of service with LWV, she answered quickly and passionately about her experience.

Our little family moved to Roseville on June 5, 1968, the day Robert Kennedy was killed. The temp was 93 degrees and I was pregnant with daughter number 2. Later that fall, while strolling with our girls around the neighborhood, a neighbor came out to chat and asked me to join LWV. Of course that was a nobrainer because I had always wanted to be a member since I had attended Girls State when I was a junior in high school. I jumped in with both feet, immediately becoming a unit leader. I started attending board meetings where, fortunately, there was babysitting. Barb sometimes played under the table and Ann would stay in her baby carrier. (Fun days!) Carolyn Cushing was president then.



I have served in every office and committee except Program (I left that for Georgeann Hall) over the years. I shared the presidency with Judy Stuthman and I still help with the budget.

In the early years, League was my lifeline to adult conversation and satisfying activity. It has continued to be stimulating, a great learning resource, and a passion. Some of the issues that have inspired me have been women's equality (we are still fighting for equal pay for equal work), an open and transparent government both locally and nationally, and a clean and safe environment to pass on to our grandchildren. Most importantly, the outstanding League women (and some men) that have become my friends sustain me and are a strategic part of my life.

League Member Judy Rosenblatt Remembered

Longtime LWV member Judy Rosenblatt passed away in December 2017. She was a longtime writer and editor for the LWV of Roseville Area and LWVMN chapters. In her dedication to the League, Judy was recognized with the Hope Washburn Award, the highest and most revered state League award.

One of the best ways to remember Judy's dedication to the League is to recall her own words about her experience. She was interviewed by fellow League member Mindy Greiling in 2013. She spoke of being very proud of a booklet of questions and answers she put together for LWVMN about arms treaties after hearing many speeches and researching the topic. After LWVMN was tasked with administering a survey by the national League, she presented the results to Senator Wendell Anderson who put the information into the Congressional Record, with her name in the record. She also spoke of being proud of her work on the LWV of Roseville Area's 25th anniversary publication. Here are some additional remembrances she had of the League.



On why LWV was important to women when she joined:

It gave women something to do that wasn't just changing diapers. They were using their brains. Today it is still the same. Women may not be escaping from diapers, but they are still using their brains. The League is about learning about things in a civil way, not taking sides until after you've studied both—or all six—sides of an issue and then and only then you decide where you stand. Then—if you have enough agreement—you can take action.

On thinking back on her work with the League:

Aside from teaching, I believe the best thing I've ever done was my work in the League of Women Voters. I frequently think: I got to travel, I saw things in Washington, D.C.,...It helped to make things more real. It was a pretty impressive thing the League did. I thought of the League as an impressive organization before I went and was even more impressed after I went there. All of us at the national meetings were treated with great respect as Leaguers. It was neat.

...I wouldn't have worked at the state league, become knowledgeable about newsletters and the like. The good friends. League gave me a chance to be proud of the things I've work on. First I worked my behind off and then was proud of it.


Voter Services Committee Report

Candidate Forums – Organized by Cecilia Warner

A Candidate Forum was provided for the only contested election in 2017 in the areas served by LWV of Roseville Area.

September 2017: Falcon Heights City Council elections candidate forum held at the Falcon Heights city offices

- The moderator was Florence Sprague .
- All seven candidates for two city council positions participated.
- About 100 people attended.
- The forum was recorded and broadcast on cable TV.





Many League volunteers assisted this year. There will be 85 citizenship ceremonies in 2018.

- 2017: 6,767 registered
- 2018 to date: 1,139 registered

High School Voter Registrations – Led by Karen Lake

- September 2017: Roseville Area High School had 1 registered, 7 forms taken to be completed.
- October 2017:
 - Fairview Alternative High School had 6 registered and 1 form taken to be completed.
 - Hill Murray High School had 7 registered and 6 forms taken to be completed.
 - Academy for Science and Agriculture had 1 registered and 3 forms taken to be completed.
- March 2018: Mounds Park Academy had 29 registered.
- April 2018: Academy for Science and Agriculture had 2 registered and 6 forms taken to be completed.
- May 2018: Voter registration is scheduled at Roseville Area High School.

All high schools in the LWV of Roseville Area cities have been contacted and offered on-site voter registrations.

- June 2017: Sherry Hood, Judy Stuthman, and Karen Lake attended a workshop entitled Civic Engagement 101, dealing with how government works at all levels.
- August 2017: Offered voter registration at Roseville Library the night of the showing of the film, "The 13th."
- October 2017: Offered voter registration at Do Good Roseville Community Volunteer Fair at Fairview Community Center.
- March 2018: Offered voter registration, in cooperation with other LWV chapters, at The March For Our Lives.
- April 2018: Offered voter registration at the Do Good Roseville/Roseville School District/LWVRA program, "Why I Run: Women Finding Their Political Voice."

Voter registration was offered at LWV of Roseville Area programs throughout the year.

presented housing committee recommendations to our city

councils.

In partnership with Metropolitan Interfaith Council on Affordable Housing (MICAH), we sent letters to local churches inviting them to join our affordable housing advocacy. Mindy presented housing information to a local church networking group.

July: Mindy and Gladys sent letters/emails to city mayors and coun-

cil members advocating for a police community mental health

officer on their police forces. None budgeted for one.

September: June Stewart sent a letter to the Roseville Review, on behalf of

League, advocating for washing dishes in lieu of using

Styrofoam trays.

October: Mindy testified in favor of amending Roseville's crime-free

ordinance to prevent it from negatively impacting people who live in apartments who call police for domestic abuse or mental health crises. After the study, the item was brought back and so

amended.

November: Mindy and MICAH presented housing information to a local

church networking group.

Year round: Gladys organized Capitol rallies and sent out many state and

national Action Alerts.

League members attended meetings on League positions, e.g.,

city comprehensive plans, police data.

March: Mindy and Rob Reinhardt represented League on a Roseville

group seeking a 28th Constitutional Amendment undoing the

Citizens United Supreme Court decision.

Observer Program

Membership Committee Report

Highlights and Activities

We ended the year with 124 members, an increase of 11, and 7 members added since January 1, 2018.

- We have 8 lifetime members, members who have committed to League for over 50 years. We are about to add 2 new members to that list: Mary Ann Palmer and Lila Recksiedler (see page 5).
- The Youth Award program continues, with 2 very strong recipients this year. The award will be presented at the annual Gavel Club dinner.
- The plan we initiated last year to respond to and follow up on inquiries received through our website has proven to be very successful.
- The Membership Committee tries to have a presence and brochures at all League functions.
- A program of orientation to League was undertaken in the fall at the Maplewood Public Library, to encourage greater visibility and membership interest in that area.
- We updated the picture directory in September. Special thanks to Judy Bergland.

- Membership can now be initiated through the website and Pay Pal as well as through completion of the traditional hard copy form.
- This year, we revised the new member packet and took steps to assure that this packet is sent promptly to all new members.
- The steps we initiated last year to enhance the flow of new member data have proven to work quite smoothly. As a result, the Treasurer receives the information and passes it on to both Membership and Data Management (for sharing with state and national organizations).
- To further facilitate efficient data sharing with the state League, we have begun to investigate the option of having new member applications submitted directly to and processed initially by the state organization. A pilot program is being contemplated.
- We have promoted membership renewals by means of an email prompt and attached form. To date, we've achieved approximately 70 renewals. We will follow up in June with those from whom we have not yet heard.
- Our focus and challenge for the immediate future is promoting the involvement of new members to assure their transition to active participation.

Communications Committee Report

The Communications Team spent time streamlining and enhancing communication with other League teams. We improved our event checklist for events to help event planners coordinate their efforts for maximum publicity.

We standardized emails so that you will receive fewer, but easier to read communications. We try to limit emails to one each week, on Fridays, except for Action Alerts and other special announcements. They all follow a similar format to make them easier to identify and to read.

We added the ability to use PayPal for payment of the Annual Meeting dinner. We will do that for other paying events that we sponsor.

The biggest changes were in *The Voter*. This year we transitioned from long-time editor Judy Berglund to our new editor, Rachel Geiser. It was a learning experience both for Rachel and for the

board. Judy Berglund was generous with her time in the transition and we were able to establish guidelines for what items are included in *The Voter*, article lengths, and publication dates. We are looking forward to our new monthly article that will highlight newer members so we can get to know each other better and also to a helpwanted section, where we will post opportunities for our members to volunteer for local League events.

64th Annual Meeting: Minutes

Minutes of the 64th Annual Meeting of the LWV Roseville Area Tuesday May 2, 2017 Little Canada City Hall

Call to Order: The 64th Annual Meeting of the League of Women Voters Roseville Area was called to order by President Rita Mills at 7:00 p.m.

Declaration of a Quorum: According to the bylaws, the presence of ten percent of our members shall constitute a quorum for the transaction of business at any meeting of the members. President Rita Mills declared a quorum was present.

Adoption of Order of Business: The Order of Business (Agenda) as printed on page 13 of the 64th Annual Meeting booklet was adopted by consent as printed, subject to emergency changes.

Appointments: After no objection, the Chair appointed as parliamentarian, Julianne Johnston.

President's Report:

Introductions: President Rita Mills introduced the current Board members, lifetime members, and thanked the host committee.

Mindy Greiling honored Georgeann Hall for 50 years of league service. A Certificate of Recognition was presented to Georgeann by President Rita Mills.

<u>Secretary Report:</u> The secretary's report is printed on pages 14 and 15 of the Annual Meeting booklet. It is customary that the Minutes of the Annual Meeting be approved by the Board at the first scheduled Board meeting following this Annual Meeting. Last years' minutes were so approved at the June 22, 2016 Board meeting.

The chair accepted a motion by Cecilia Warner that the Minutes of the 64th Annual Meeting of the LWV Roseville Area, May 2, 2017, be approved by the Board at the June 28, 2017 Board meeting. This motion was seconded by Sherry Hood, and the motion carried unanimously.

<u>Treasurer Report:</u> The Treasurer's Report for 2016-2017 is on page 16 of the Annual Meeting booklet. In the absence of the Treasurer, President Rita Mills asked for questions regarding the report. There were no questions. The Treasurer's Report will be filed for examination. Joyce Briggs motioned for approval of the Treasurer's Report and the motion was seconded by Beth Salzl. The motion carried unanimously.

<u>Committee Reports:</u> Committee chairs were introduced and each committee chair gave a short summary of past year activities and challenges. Cecilia Warner represented Voter Services; Mindy Greiling represented Programs; Bonnie Koch represented the Affordable Housing Study Report; Beth Reinhart represented Membership; Barb Anderson represented Communications; and President Rita Mills substituted for Gladys Jones in representing Advocacy.

Action Items:

Presentation and Approval of the 2017-2018 Budget:

In the absence of the Budget chair, Mary Ann Palmer, President Rita Mills read relevant emailed comments from Treasurer Teri MacNabb. Mills reported that the LWV of Roseville Area 2017-2018 Proposed Budget, on page 17 of the 64th Annual Meeting booklet, was prepared by the Budget committee. Barb Anderson motioned to approve the LWV of Roseville Area 2017-2018 Proposed Budget. Shirley Bradway seconded the motion. The motion carried unanimously.

Approval of Bylaws Revision:

Article III Types of Membership: *Persons at least 16 years of age who join the League shall be voting members of local LWVs, state Leagues and of the LWVUS.* June Stewart motioned that the Bylaws Revision be approved. Nancy Irsfeld seconded the motion. The motion carried unanimously.

64th Annual Meeting: Minutes

Action Items:

Approval of Affordable Housing Report and Recommendations:

Georgeann Hall motioned that the Affordable Housing Study Report and Recommendations be approved. This motion was seconded by Joyce Briggs. The motion carried unanimously.

Approval of Second Year of Affordable Housing Study with Focus on Advocacy:

Karen Lake motioned to approve the second year of the Affordable Housing Study with a focus on advocacy. This motion was seconded by Jim DeBenedet. The motion carried unanimously.

Adoption of Local Program for Action.

Program chair, Mindy Greiling presented the *Positions of the League of Women Voters – Roseville Area* on pages 18 and 19 of the 64th Annual Meeting booklet. A new Local Study Item, to continue the Affordable Housing Study with a focus on advocacy, was the only change. Mindy Greiling motioned to adopt the continuing local program positions, including the new Local Study Item, as added to the Program for Action. Carolyn Cushing seconded the motion. The motion carried unanimously.

Presentation and Approval of Nominating Committee Report:


